- Add \$25.00 per cubic yard for additional mixing fee if any material added to truck at jobsite.
- Add \$60.00 (plus tax) for pump washout fee if any discharged mix is put in truck for disposal, additional fee (stand-by charges) will be incurred for time in excess of 40-minutes.

TERMS AND CONDITIONS OF SALE

- 1 **STRENGTH AND QUALITY:**
 - a. Compressive strength is guaranteed in accordance with current A.S.T.M. Standard C-94 for concrete delivered with slumps up to a maximum of 4" or design slump tolerances. Where the customer requests concrete of greater slump than specified, the strength is not guaranteed unless the additional cement required to maintain the designed water-cement ratio is added and charged accordingly. Concrete mix(es) temperatures bid per ACI 305-1.06
 - b. The seller is not responsible for the slump, strength and quality of any concrete to which water or other material has been added by the customer. The seller does not guarantee finished work.
- 2 **YIELD:** The seller will not guarantee "in place" yield, "in the form" yield, or any other yield calculation except by measurement in accordance with A.S.T.M.
- 3 **SAMPLING AND TESTING:** All sampling and testing shall be in accordance with the latest applicable A.S.T.M. Standards. Unless specifically stated, prices do not include costs for testing or other engineering services. A charge will be made for taking, handling, storing and testing concrete cylinders.
- 4 **CEMENT AND AGGREGATE:**
 - a. Prices are based on use of standard Type I or Type II Portland Cement in "bulk", and standard local aggregates with 1" top size.
 - b. Concrete with special type cement and concrete mixes specifying other than 1" maximum size aggregates will be priced on application.
- 5 **OVERTIME AND HOLIDAY DELIVERIES:** The regular work day for all concrete deliveries is considered to be between the hours of 5:00 A.M. and 5:00 P.M., Mondays through Fridays. Saturday is not considered a regular work day and scheduling will be at seller's discretion. There will be an overtime charge for deliveries scheduled to commence before 5:00 A.M. and after 5:00 P.M., Mondays through Fridays, and on Saturdays. (See Ready Mix Price List).
- 6 **DETENTION OF TRUCKS AT THE JOB SITE:** Concrete delivered prices are based on six (6) minutes free unloading time per cubic yard or thirty (30) minutes free unloading time per load, whichever is greater. Unloading delays of more than six (6) minutes per cubic yard or thirty (30) minutes per load will be charged to the customer at the rate of two dollars (\$2.00) per minute for all such excess unloading time.
- 7 **WASH DOWN AREA:** The customer agrees to provide an area on the delivery site, proximate to the delivery location, for the cleaning and wash down of delivery chutes following completion of delivery. Should the customer fail to provide or specify an area for cleaning and wash down, seller may assume that the entire job site is available for such cleaning and wash down. We will not assume liability for any damage or trespass as a result of this cleaning and wash down, and the customer agrees to indemnify and hold Hawaiian Cement harmless against all liabilities, loss and expense incurred as a result of any damage or trespass caused by such cleaning and wash
- 8 **DELIVERY:**
 - a. Prices are f.o.b. job site, over suitable access roads. The seller reserves the right to stop delivery if access roads are not suitable.
 - b. When the customer orders delivery beyond the street curb, he assumes responsibility for damage to sidewalks, driveways, or other property, and agrees to indemnify and hold the seller harmless against all liabilities, loss and expense incurred as a result of such deliveries.
 - c. All delivered concrete prices are for minimum loads of five (5) cubic yards. For less than five (5) cubic yards, an additional charge will be made.
 - d. One cleanup load of less than five (5) cubic yards will be allowed for each day's pour, at each job, at job prices. All additional cleanup loads will be charged at minimum haul rates.
 - e. The size of concrete loads in excess of five (5) cubic yards will be at the option of the seller.
 - f. All concrete correctly dispatched and with delivery underway is for the customer's account.
- 9 **TAX:** Applicable State Gross Income Tax will be charged on all sales.
- 10 **TERMS:** Payment on all purchases is due not later than thirty (30) days following the last day of the month in which the purchase was made. All balances not paid within thirty (30) days will be considered delinquent and shall bear interest at the rate of one and one-half percent (1.5%) per month from and after the first day the same became delinquent. A prompt payment discount of one percent (1%) will be allowed on all payments received by the 10th of the month following purchase, provided that all previous charges have been paid in full.
- 11 **DELAYS:** The seller will not be responsible for failure to make delivery when prevented by strikes, lockouts or other labor troubles, accidents or necessary repairs to machinery, fires, flood, adverse weather conditions, or by reasons of any other contingencies beyond the seller's control. Seller will not be responsible for allocations or priorities that may be imposed by its suppliers.
- 12 **PRICE DURATION:** Prices are subject to immediate change in seller's sole and reasonable discretion, for any reason, including but not limited to; any increase of cement prices, fuel, or power to seller by it's suppliers. If sacked cement is used because of unavailability of bulk, prices will be increased. Prices, terms and conditions are for the periods set forth in this proposal providing they are accepted within thirty (30) days of quotation date, and substantial work begins within ninety (90) days from quotation date and continues uninterrupted until completion. Extension of the time period will be cause for renegotiating prices.
- 13 **EXCEPTIONS & CLAIMS:** Shall be deemed waived unless made in writing within ten (10) days from time of delivery. Seller shall be given full opportunity to
